(Annual percentage change in value)



(Annual percentage change)








**World trade in commercial services by selected region, 1998-05**





(Billion dollars)



(Percentage based on value data)



(Billion dollars)



(Percentage based on value data)



(Billion dollars)



(Percentage based on value data)



(Billion dollars)



(Percentage based on value data)



(Billion dollars)



(Percentage based on value data)



(Billion dollars)



(Percentage based on value data)



(Billion dollars)



(Percentage based on value data)





**Merchandise exports of least-developed countries by selected product group and destination, 2004**











(Percentage of total value)


