Introduction

Before the current Customs legislation, in Cape Verde, centuries ago payments for services rendered by customs officials before or after the normal working time were paid by customs users requesting such services.

Nowadays, the current Customs Organic Statute, approved by the Decree No. 43199 of 29 September 1960, establishes the following in its article 278:

«The overtime services rendered to the requesting Customs users, before or after the normal working time within the customs Houses or outside the Customs House zone at anytime will be charged to such requesting users as emoluments for the personnel and other allowances for transports, accommodations and meals, according to the approved rates established by Ministerial Ordinance».

Outside the customs house, such services can only be exceptionally authorized and rendered within the normal working time.

The accommodation and meal allowances must be paid according to the same provisions generally applied within the Public Administration.

The services rendered by customs officials concern to:

- services rendered to ships and airplanes;
- custody, watching and checking of loading and unloading goods, customs warehouses, ports, airports, roads, ships, airplanes and territorial sea;
- Verification and reverification of goods.

As air and shipping companies from 1978 onwards refused to pay charges for loading and unloading of their ships and planes, for conveyance of goods within the port and airports, as well as other charges and other customs services rendered by customs, ports and airports officials, the government published the Ministerial Ordinance No. 71/78 of 14 of October 1978 amending the former Ministerial Ordinance No. 6238/61 of 28 November 1968. In its turn, the Ministerial Ordinance No. 23/79 of 27 April 1979 amended the Ministerial Ordinance No. 71/78. By Ministerial Ordinance No. 29/91 of 28 August 1991 the three Ministerial Ordinances No.6238/61, 71/78 and 23/79 were revoked and a new table of customs users fees was adopted. This table was amended successively by Ministerial Ordinances No. 60/2001 of 29 October 2001, No. 9/2002 of 15 September 2002, No.18/2003 of 8 September 2003, No. 14/2004 of 14 July 2004 and 36/2004 of 13 September 2004.

Until 1992, the emoluments for the personnel had a maximum limit of 60% of the annual salary of each member of the staff. From there on, the emoluments for the personnel were integrated in the customs staffs' salary while they were collected.

The total amount collected on pretence of remunerations for services rendered by particular customs users, according to Ministerial Ordinance No. 29/91 of 28 August 1991, is classified in two categories:

- customs users fee of 1.04 % ad-valorem on imported goods transported by sea, and
- other customer users' fees.

The above include both emoluments for the personnel and other allowances.

Of this total amount, there are:

- the emoluments for the personnel which constitutes: budgetary revenue,
- travel allowances, accommodation and meal expenses which are paid directly to the customs officials by the Customs House.

Of the 1.04% *ad-valorem* customs users' fees, 0.28 % goes to emoluments for the personnel. The remaining 0.76 % is affected for direct payment for customs officials.

In conclusion:

- 1- Customs users fee are split into:
- a) emoluments for the personnel that constitutes budgetary revenues.
- b) allowances for the personnel paid directly monthly to customs officials by the Customs House.

- 2- Other customs users' fees:
- *a)* Emoluments for the personnel that constitutes budgetary revenues.
- b) Allowances for the personnel paid directly and monthly to customs officials by the Customs House.
