Ref: Fees for Business Registration

GENERAL RULE

Section 29.2 of the Executive Law provides that the Ministry of Commerce and Industry is responsible among other things, for conducting the registration of business enterprises.

The Revenue Code of 2000, as Amended in 2010, Part VIII Finance and Fiscal, Chapter 21, Government Agency Fees, Section 2101, Fees Imposed stipulates that every person who, or legal person which consumes services or uses a privilege or right under the control of Government shall obtain from the appropriate Government agency, institution, or Ministry a permission, permit or instrument for which he or it shall pay or cause to be paid into the consolidated fund and available for appropriation by the Legislature for the general purpose of the Government.

The Revenue Code of 2000, as Amended in 2011, Part VIII, Finance and Fiscal, Chapter 21, Government Agency Fees, Section 2101, Ministry of Commerce and Industry provides that fixed fees for business registration and other services shall be prescribed by regulation issued by the Minister of Commerce and Industry in consultation with the Minister (Minister of Finance and Development Planning) and shall be assessed by the Minister for Commerce and Industry and paid regularly to the Minister for deposit into the account of Government.

The Revenue Code of 2000, as Amended in 2011, Part I, Chapter 1, General Provisions, Subchapter C. Additional Criminal Offenses, Section 92. Knowing Failure to Obtain Required License or Registration states that any person who knowingly engages in any business, enterprise, trade, service, occupation or profession for which annual license is required under the provisions of this Title or any other statute, without having obtained such license is guilty of a misdemeanor and upon conviction, in addition to other sections provided by law, shall be fined not more than US\$25,000.00 or be imprisoned not more than 30 days or both.

PUBLIC NOTICE

It is hereby regulated with immediate effect that the following fees herein contained shall be assessed by the Ministry of Commerce and shall be paid to the Liberia Revenue Authority. The registration fees that are in United States Dollars are to be paid either in United States Dollars or in Liberian Dollars at the prevailing rate of exchange published by the Central Bank of Liberia in effect on the day the payment is made. WHEREAS, the Government intends to be in compliance with the obligations of the World Trade Organization;

WHEREAS, the fees will be applied on the anniversary of the date of the first payment;
