TRADES TAX ACT

(Cap 240)

Trades Tax (Common Market For Eastern and Southern Africa Free Trade Area) Regulations, 2009

In exercise of the powers conferred by section 11 of the Trades Tax Act, the Minister responsible for Finance makes the following Regulations—

1. These Regulations may be cited as the Trades Tax (Common Market For Eastern and Southern Africa Free Trade Area) Regulations, 2009, and shall be deemed to have come into operation on 1st May, 2009.

Citation

2. In these Regulations—

Interpretation

“certificate” means the certificate of origin which is issued in accordance with the Treaty;

“Member State” means a member State of the COMESA Free Trade Area;

“Treaty” means the Treaty for the Establishment of the Common Market For Eastern and Southern Africa (COMESA).

3. These Regulations apply to the Member States listed in Schedule 1.

4. For the purpose of these Regulations, except for those goods specified in Schedule 2, trades tax shall not be payable on goods in accordance with Article 46(1) of the Treaty, where they —

No customs
duty payable

(a) originate from a Member State; and

(b) are covered by a certificate:

Provided that a law of the Member State extends similar treatment to import of goods from Seychelles.

5.(1) The Comptroller of Taxes shall refuse a certificate and declare it to be invalid, where he or she has reason to believe that the certificate is incomplete, false or misleading.

(2) Where a certificate is declared to be invalid under subregulation (1), regulation 3 shall not apply with respect to those goods specified in Schedule 2.
