ON FURTHER STRENGTHENING OF CONTROL OVER IMPORTATION, EXPORTATION AND TRANSIT  
THROUGH UKRAINE'S TERRITORY OF EXCISABLE ALCOHOL BEVERAGES AND TOBACCO PRODUCTS

In order to strengthen control over the import, export and transit through the territory of Ukraine  
of excisable alcohol beverages and tobacco products, the Cabinet of Ministers of Ukraine hereby  
**RESOLVES:**

1. To approve a List of Customs Border Entry Points of Ukraine, through which the Excisable  
Alcohol Beverages and Tobacco Products falling under UCG FEA codes 2203 00, 2204 - 2208,  
2402 10 00 00, 2402 20 10 00, 2402 20 90, 2403 10 10 00, 24 03 10 90 00, 2403 99 10 00, are  
brought into for Import and Transit Purposes and are brought out (attached hereto).

2. To prescribe that the products (items) specified in Item 1 of this Resolution shall be imported and carried through Ukraine's territory without a change in the mode of transportation and a transport vehicle, except for cases relating to the use of sea vessels at points where the customs border is crossed.

Procedures for customs control over products (items) in case of change of the transport vehicle shall be laid down by the State Customs Committee.

3. The State Customs Committee shall prepare and approve conditions that must be complied with by declarants of excisable alcohol beverages and tobacco products.

4. To repeal Resolution of the Cabinet of Ministers of Ukraine No. 856 of 30 July 1996, "On Amendment of the Resolution of the Cabinet of Ministers of Ukraine No. 484 of 6 May 1996".
