RESOLUTION

938 of August 12, 1996

Kyiv

On further reinforcement of control over import, export and transit of excisable alcohol beverages and tobacco goods at the territory of Ukraine

In order to reinforce the control over import, export and transit of excisable alcohol beverages and tobacco goods at the territory of Ukraine, Cabinet of Ministers of Ukraine **RESOLVES**:

1. To approve the list of entry points at the state border of Ukraine, through which the excisable alcohol beverages and tobacco products (UKR FEA codes 2203 00, 2204 - 2208, 2402 10 00 00, 2402 20 10 00, 2402 20 90, 2403 10 10 00, 24 03 10 90 00, 2403 99 10 00) are imported, transited and exported.

2. To establish that the goods (products) listed in item 1 of this resolution shall be brought in and moved through the territory of Ukraine without changing mode and mean of transportation, with exception of the use of sea transport at the cross border points.

In case of changing transportation mean, the procedure of customs control over goods (products) shall be defined by the State Customs Committee.

3. The State Customs Committee shall develop and approve the criteria which the declarants of excisable alcohol beverages and tobacco products must meet.

4. To cancel the CM Resolution # 856 of July 30, 1996 "On amendment of the CM Resolution # 484 of May 6, 1996".
