THE LAW OF UKRAINE

"On Eliminating the Ban on Exports of Waste Alloyed Ferrous Metals and Waste Non-Ferrous Metals, and Semi-Finished Products thereof"

I The Verkhovna Rada of Ukraine hereby decrees:

1. Approve of the following export duty rates for goods exported outside Ukraine:

2. In the process of determining the customs value of goods and payment of the duty a foreign currency shall be recalculated to the Ukrainian currency at the official exchange rate of the National Bank of Ukraine as of the day of submitting the customs declaration.

The export duty shall be charged by customs authorities of Ukraine and paid by the agents of foreign economic activity to the State Budget exclusively in the form of current assets before or during the customs clearance of goods.

3. From the date this Law comes into effect, the goods listed in Article 1 of this Law shall be exempt from the free trade regime with foreign states. The Cabinet of Ministers of Ukraine shall within a month notify the foreign states about such exemptions.

4. In the process of exporting the goods listed in Article 1 of this Law and goods under UCN FEA codes 7308 90 99 00, 8417 90 00 90, 8431 39 10 00, 8454 20 00 00, 8474 90 90 10, 8480 10 0 00, 8480 20 00 00, 8514 90 80 00, their assigning to the classification groups noted in UCN FEA shall be carried out under the approval of the central body of the executive power on industrial policy issues.

5. Article 9 of the Law of Ukraine "On Scrap Metal" (Vidomosti Verkhovnoi Rady Ukrayiny, 1999, No.25, p. 212; 2003, No.6, p.52) shall be worded as follows:

"Article 9. Export of Scrap Metal.

During 5 years after the validation of the Law "On Eliminating the Ban on Exports of Waste Alloyed Ferrous Metals, Waste Non-Ferrous Metals and Semi-Finished Products thereof", only the specialized metallurgic processing enterprises shall export the goods (semi-finished products) made of waste non-ferrous metals, alloys thereof and goods made of non-ferrous metals, provided these enterprises produce these goods and posses the export quality certificate. The system of quality management at these enterprises should meet the requirements of ISO 9000-2001 standards or the following ones confirmed by the quality certificate".

6. To supplement Part five of Article 5 of the Law of Ukraine "On Tolling Operations in Foreign Economic Activity" (Vidomosti Verkhovnoi Rady Ukrayiny, 2002, No.6, p. 40; 2005, No.18-19, p.267) with the following:

"The goods listed in Article 1 of the Law of Ukraine "On Eliminating the Ban on Exports of Waste Alloyed Ferrous Metals, Waste Non-Ferrous Metals and Semi-Finished Products thereof" can be exported outside the customs territory of Ukraine as raw materials only if the export duty is paid in advance into the State Budget in current assets (promissory notes or other such forms of payments are not permitted)".

7. Within a month after the publication of this Law, the Cabinet of Ministers of Ukraine shall bring its legal-normative acts in compliance with this Law.

8. This Law comes into effect from the day of accession of Ukraine into the World Trade Organization.
