THE LAW OF UKRAINE

On Amending the Law of Ukraine "On Export Duty Rate for Live Bovine Animals and Leather Raw Materials"

The Verkhovna Rada of Ukraine hereby decrees to:

I. Make amendments to the Law of Ukraine "On Export Duty for Live Bovine Animals and Leather Raw Materials" (Vidomosti Verkhovnoyi Rady Ukrainy, 1996, No.28, p. 133), to read as follows:

"The Law of Ukraine

On Export Duty for Live Bovine Animals and Leather Raw Materials

To protect the Ukrainian consumer market, interests of domestic producers, and with the purpose of further improvement of the export structure the Verkhovna Rada of Ukraine hereby decrees to:

Establish the following export duty rates for live bovine animals and leather raw materials:

Starting January 1, 2007 the export duty rate for products under codes according to UPC FEA 4101, 4102, 4103 90 00 00 shall be annually decreased by 1 percentage point down to the value of 20 per cent".
