THE LAW OF UKRAINE

"On Eliminating the Ban on Exports of Waste Alloyed Ferrous Metals and Waste Non-Ferrous Metals, and Semi-Finished Products thereof"

I The Verkhovna Rada of Ukraine hereby decrees:

1. Approve of the following export duty rates for goods exported outside Ukraine:

2. Article 9 of the Law of Ukraine "On Scrap Metal" (Vidomosti Verkhovnoi Rady Ukrayiny, 1999, No.25, p. 212; 2003, No.6, p.52) shall be worded as follows:

During 3 years after the validation of the Law "On Eliminating the Ban on Exports of Waste Alloyed Ferrous Metals, Waste Non-Ferrous Metals and Semi-Finished Products thereof", only the specialized metallurgic processing enterprises shall export the goods (semi-finished products) made of waste non-ferrous metals, alloys thereof and goods made of non-ferrous metals, provided these enterprises produce these goods and posses the export quality certificate. The system of quality management at these enterprises should meet the requirements of ISO 9000-2001 standards or the following ones confirmed by the quality certificate".

- 3. Within a month after the publication of this Law, the Cabinet of Ministers of Ukraine shall bring its legal-normative acts in compliance with this Law.
- 4. This Law comes into effect from the date of accession of Ukraine into the World Trade Organization.
