

# THE LAW OF UKRAINE

## On Amendment of the Law of Ukraine “On Export Duty for Waste and Scrap of Ferrous Metals”

---

The Verkhovna Rada of Ukraine hereby decrees to:

I. State the Law of Ukraine “On Export Duty for Waste and Scrap of Ferrous Metals” (Vidomosti Verkhovnoyi Rady Ukrayiny, 2003, No.1, p.1) in the following wording:

### “THE LAW OF UKRAINE On Export Duty for Waste and Scrap of Ferrous Metals

The Verkhovna Rada of Ukraine hereby decrees:

Article 1. To approve the following export duty rates for goods exported outside Ukraine:

In the year when Ukraine accedes to the World Trade Organization export duty rates come into force from the moment of accession until December 31 of such year.

Export duty rates come into force from January 1 to December 31 of the

relevant year after the accession of Ukraine to the World Trade Organization.

In the years following the seventh year after the accession of Ukraine to the World Trade Organization, the export duty rates are applied at the level of the seventh year.

2. The present Law shall take legal effect on the date of Ukraine's accession to the World Trade Organization.
