The contractual cost of works shall be determined in accordance with international practices, taking into account the necessary scope of studies to be performed, their complexity and deadlines for their performance.

A contract shall be entered into and expert examinations and registration tests of domestic preparations shall be calculated in Ukrainian hryvnias.

A contract shall be entered into and expert examinations and registration tests of imported preparations shall be calculated in foreign currency (Euros, US dollars at the exchange rate set by the National Bank of Ukraine or in Ukrainian hryvnias if the registration is effectuated by a representative office of an ordering company in Ukraine).
