On Restructuring of SJSC "Khlib Ukrainy"

(As amended pursuant to Resolution No. 690 of the Cabinet of Ministers of Ukraine (690-2003-π) dated 15 May 2003)

[It is hereby resolved]

1. To establish a Government Commission for Restructuring of SJSC "Khlib Ukrainy", which consists of members listed in Addendum 1.

To permit the Chairman of the Commission to change Commission members on a need-be basis.

To charge the Chairman of the Commission with approving the Enabling Rules on the Commission, specifying that its main goals shall be as follows:

coordination of activities of central and local agencies of executive power, which activities are aimed to financially rehabilitate the Company;

review of proposals from central and local agencies of executive power, governing bodies of the Company as to further restructuring of the Company, including liquidation, re-organization of existing subsidiaries and establishment of new subsidiaries, and undertaking of measures to accomplish same pursuant to prescribed procedures;

confirmation of documents concerning the restructuring of the Company, and submission of corresponding proposals.

- 2. To approve a Plan for Restructuring of the Company pursuant to Addendum 2. (As a partial change to Item 2, to authorize the Chairman of the Government Commission for Restructuring of the Company to make changes to the Plan for Restructuring of the Company on a need be basis, pursuant to Resolution No. 690 of the Cabinet of Ministers of Ukraine (690-2003-p), dated 15 May 2003)
- 3. To agree with a proposal from the Ministry of Agrarian Policy and SJSC "Khlib Ukrainy" regarding:

a transfer of SJSC "Khlib Ukrainy" into the sphere of management of the Ministry of Agrarian Policy;

singling out from the Company of the branch "Agency for Restructuring of Enterprises in the Agro-Industrial Complex" and establishment based on this branch of the State Enterprise "Agency for Restructuring of Debts of Enterprises in the Agro-Industrial Complex", with a transfer thereof into the sphere of management of the Ministry of Agrarian Policy.
