RESOLUTION

of 18 January 2003, No. 93

Kiev

On Charging of Fee for the Customs Clearance of Goods and Vehicles Performed Out of the Location of Customs Bodies or Beyond the Hours of Operation Set for Customs Bodies

In Accordance with Article 71 of the Customs Code of Ukraine, the Cabinet of Ministers of Ukraine hereby **RESOLVES**:

1. To approve the amount of fee charged for the customs clearance of goods and vehicles performed out of the location of customs bodies or beyond the hours of operation set for customs bodies (annexed).

2. To establish that:

The fee for the customs clearance of goods and vehicles performed out of the location of customs bodies or beyond the hours of operation set for customs bodies (hereinafter "fee") shall be levied on persons importing goods and vehicles across the customs border of Ukraine on the basis of their written appeal requesting such manner of customs clearance to be applied;

The fee shall be charged in national currency in the amount stipulated in paragraph 1 of this Resolution, at the official rate of exchange fixed by the National Bank as of the date of payment of such fee;

The proceeds from the charging of fee shall be received by the State Budget as revenue;

The procedure for the adoption of decision regarding the performance of customs clearance of goods and vehicles out of the location of customs bodies or beyond the hours of operation set for customs bodies, for the assessment of the amount of fee, and for the payment thereof shall be established by the State Customs Service.

3. To introduce the following amendments to Clause 2 of the Resolution of the Cabinet of Ministers of Ukraine of 8 October 1998, No. 1625 *On Export of Certain Varieties of Goods to the Republic of Moldova* («Ofitsiyniy Visnyk Ukrayiny», 1998, No. 41, p. 1514):

In paragraph one delete the following passage: "paragraph two of clause 1 of the Resolution of the Cabinet of Ministers of Ukraine of 27 January 1997, No. 65 *On Custom Duty Rates* in wording of the Resolution of the Cabinet of Ministers of Ukraine of 7 March 1998, No. 285 ("Ofitsiyniy Visnyk Ukrayiny"), 1998, No. 10, p. 381, No. 19, p. 706)";

Delete paragraph two.

- 4. To deem no longer valid the Resolutions of the Cabinet of Ministers of Ukraine as set forth in the annexed list.
- 5. This Resolution shall come into force on January 1, 2004.
