RESOLUTION

of 25 December 2002, No.1987

Kiev

On Approval of the List of Crossing Points for Automobile Traffic across the State Border of Ukraine with the Purpose of Bringing across by Citizens of Vehicles and of Chassis and Bodies for Vehicles

As amended by the Resolution of the Cabinet of Ministers of Ukraine
of 18 January 2003, No. 92

In Accordance with part two of Article 95 of the Customs Code of Ukraine, the Cabinet of Ministers of Ukraine hereby **RESOLVES**:

1. To approve the List of crossing points for automobile traffic across the state border of Ukraine with the purpose of bringing across by citizens of vehicles and of chassis and bodies for vehicles (annexed).

Citizens shall import into the customs territory of Ukraine via the listed crossing points, vehicles according to UCCFEA code designations 8701, 8702, 8703, 8704, 8705, 8711, and 8716, and chassis and bodies according to code designations 8706 and 8707 for vehicles of commodity positions 8701 through 8705:

For unrestricted use;

In the temporary import regime, conditional on payment of taxes and duties stipulated by law;

With the purpose of transit, conditional on deposition of statutory cash pledge.

2. This Resolution shall come into force on January 1, 2004.
