DECISION OF THE PRIME MINISTER ON REVISIONS OF THE LIST OF IMPORTED GOODS SUBJECT TO TARIFF RATE QUOTAS

THE PRIME MINISTER

Pursuant to the Law on Government Organization of 25 December 2001; Upon proposal made by the Minister of Trade in the official document No.065/TM-XNK dated 17 February 2005,

DECIDES:

Article 1. To abolish tariff rate quotas on the imported items numbered (1), (2), (4), $(7)^*$ in the List of imported goods subject to tariff rate quotas issued in association with the Decision No.91/2003/QD-TTg dated 9 May 2003 of the Prime Minister.

Article 2. This Decision shall take effect as from 1 April 2005.

Article 3. Ministers, Heads of ministerial-level agencies, Heads of agencies under the Government's authority, Chairmen of the People's Committees of provinces and cities under the Central authority shall be responsible for guiding the implementation of this Decision./.
