In pursuance of Annex A of the Protocol, the delegation of Mexico has notified, for the information of participating countries, modifications made on 1 January 1978 to the list of Mexican authorities entitled to issue certificates of origin and the stamp used by these authorities, as well as to the name of the Mexican authorities which deal with enquiries regarding certification of origin. Accordingly, page 54 of document CPC/10, as modified by CPC/10/Add.3 and 8, should be replaced by the following page, and paragraph 8 on page 78 of CPC/10 should be modified to read:
