### URUGUAY

Attached is a report received by the TSB on the present status of restrictions on trade in textiles maintained by Uruguay. This report was submitted in reply to the TSB's request for information in pursuance of Article 11 of the Arrangement, and in particular paragraphs 11, 12 and 2 thereof.
