Dear Mr. Wong:

I refer to paragraph 3 of the Agreement between the United States of America and the Republic of Singapore relating to Trade in Cotton, Wool, and Man-Made Fiber Textiles and Textile Products, with annexes, effected by exchange of notes September 21 and 22, 1978 as amended ("the Agreement") and to your letter of June 20, 1980 concerning exports from Singapore to the United States of products classified in textile categories 317 and 341.

On behalf of my Government, I have the honor to propose that the consultation level for Category 317 be increased to a level of 14,627,272 square yards for the 1980 agreement year and that the consultation level for Category 341 be increased to a level of 58,000 dozen for the 1980 agreement year.

If this proposal is acceptable to your Government, this letter and your letter of confirmation shall constitute an amendment to the Agreement.
