## ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

### Notification under Article 4:4

#### Amendment to the Agreement between the United States and Colombia

The Textiles Surveillance Body has received a notification from the United States of a further amendment to its bilateral agreement with Colombia, concluded under Article 4 of the Arrangement.

The TSB, pursuant to its procedure regarding bilateral agreements notified under Article 4<sup>2/</sup>, has examined the relevant documentation and is circulating the text of the notification to the participating countries.<sup>3/</sup>

UNITED STATES LETTER

Bogota, Colombia  
31 July 1980

Dear Dr. Perez,

I refer to the Agreement between the United States of America and the Republic of Colombia relating to trade in cotton, wool, and man-made fibre textiles and textile products, effected by exchange of notes 3 August 1978, as amended (the Agreement) and to your letter of 24 June 1980 concerning exports from Colombia to the United States of products classified in the United States textile Category 444 (women's, girls' and infants' wool suits).

On behalf of my Government, I have the honour to propose that paragraph 5 of the Agreement be amended to establish a specific limit for Category 444 beginning with a level of 230,000 square yards equivalent for the 1979-1980 Agreement year.

If this proposal is acceptable to your Government, this letter and your letter of confirmation shall constitute an amendment to the Agreement.
