ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4:4

Modification to the Bilateral Agreement
between the EEC and Hungary

The Textiles Surveillance Body has received from the European Communities notification of two modifications to the bilateral agreement between the EEC and Hungary.¹

The TSB, pursuant to its procedure regarding bilateral agreements notified under Article 4 ^{2/} has examined the relevant documentation and is transmitting the text of these notifications to participating countries.

AGREED MINUTE (1)

1. Following a request submitted in a Note Verbale by the Commission, dated 30 December 1980, delegations of the Hungarian People's Republic and the European Economic Community met at Brussels on 5 February 1981 for consultations in connexion with the implementation of the bilateral EEC/Hungary Agreement on trade in textile products initialled on 30 November 1978.

2. At these consultations, Hungary agreed to limit its exports of cotton yarn (category 1) to the Benelux and of gloves (category 11) to France, from 1 January 1981 to 31 December 1982, to the following annual levels:

3. It is the understanding of both parties that the provisions of the Agreement which concern exports of products subject to quantitative limits, and in particular the licensing procedures set out in Protocol A of the Agreement, will apply to exports of products in the above-mentioned categories as from 6 February 1981.

From that date, the Hungarian authorities will issue export licences and certificates of origin for all exports of products in the above-mentioned categories. It is understood that products shipped between 1 January and 6 February 1981 will be deducted from the limit fixed for 1981.

AGREED MINUTE (2)

1. Following a request submitted in a Note Verbale by the Commission, dated 20 September 1980, delegations of the Hungarian People's Republic and the European Economic Community met at Brussels on 27 November 1980 and 5 February 1981 for consultations in connexion with implementation of the bilateral EEC/Hungary Agreement on trade in textile products initialled on 30 November 1978.

2. At these consultations, Hungary agreed to limit its exports of cotton yarn (Category 1) to Italy to the following annual levels:

1981 250 tonnes

1982 251 tonnes

Exceptionally, an additional quantity of 30 tonnes may be exported during 1981.

3. As regards exports of cotton yarn put up for retail sale (Nimexe Code 55.05-13 and 19), Hungary undertakes to take into account the proportions already established in trade flows for this category.

4. It is the understanding of both parties that the provisions of the Agreement which concern exports of products subject to quantitative limits, and in particular the licensing procedures set out in Protocol A of the Agreement, will apply to exports of products in the above-mentioned category as from 6 February 1981.

From that date, the Hungarian authorities will issue export licences and certificates of origin for all exports to Italy of category 1 cotton yarn.
