#### 2. Submission of Lists of Requests

The procedures for the preparations for the Conference (L/408, Annex, para. 13(a)), called for the submission of request lists by 1 October. Each government was asked to submit a list of requests to each other government with which it desired to negotiate and to send forty copies to the secretariat for distribution to the other participants. The lists thus far received by the secretariat are enumerated in Annex A.

#### 3. Copies of Tariffs and Trade Statistics

The procedures for the preparations for the Conference (L/408, Annex, para. 13(b)) required each government to send to the secretariat two copies of the latest edition of its customs tariff and two copies of its foreign trade statistics for 1953 and 1954. The tariffs and statistics thus far received are enumerated in Annex B. Governments which wish to obtain copies of tariffs and statistics or other information from other participants were requested to address their enquiries directly to them.

### 4. Consolidated Lists of Offers

The consolidated lists of offers are to be submitted at the opening of the Conference on 18 January. It is proposed that they be prepared in the following form:

#### 5. Statistical Data relating to the Lists of Offers

It was suggested in the Report of the Intersessional Working Party (L/408, Annex, para. 15) that it would be helpful to participating countries, and also to the secretariat in preparing for the Committee's review of the offer lists, if each participating government would furnish with its consolidated list of concessions a statistical analysis showing the value of imports of the items on which concessions are being offered. The Government of the United States has indicated that it can furnish an analysis on the lines set out in Annex C and it is proposed that other participating governments should endeavour to do the same.
