## NOTE VERBALE FROM ROMANIA

The following communication dated 17 June 1975 has been received from the Permanent Mission of Romania.

---

With reference to the Protocol relating to Trade Negotiations Among Developing Countries, I have the honour to enclose herewith the lists of additional products of export interest to Romania in the markets of Yugoslavia, Spain, Turkey, Egypt, Pakistan, Brazil, Peru, Uruguay, Chile, Mexico, Greece, Israel, India and the Philippines.

These products, which are not included in the existing schedule of concessions under the Protocol concluded between sixteen countries, could be the subject of an exploratory discussion on the occasion of the consultations that are to take place between Romania and the participating countries on the basis of the initial list of products communicated by Romania (document CPC/11).

I would appreciate your taking the necessary action to communicate these lists to the countries concerned.
