COMMUNICATION BY TUNISIA

The following communication has been received from the Permanent Mission of Tunisia in connexion with the statistical data circulated in L/5367/Add.1, pages 6-9.

With respect to the statistical data on imports by Tunisia of products included in its schedule of concessions, the following remarks are relevant:

1. Import trend

After an increase of the order of 69.6 per cent in 1980 in relation to 1979 (from D 6,890,000 to D 11,649,000), the value of Tunisia's imports of products covered by the Protocol of the 16 dropped back appreciably in 1981, by 42.5 per cent in relation to 1980 and by 3 per cent in relation to 1979.

The extent of this decline should be qualified:

- while imports of certain products (such as cotton yarn) dropped back very substantially, those of other products (such as generators) showed a significant increase (see table below);
- this table reflects a more balanced distribution of products imported from participating countries since imports are no longer concentrated on one single product.

2. Level of these imports

In the period 1979 to 1981, imports by Tunisia covered by the Protocol of 16 represented respectively 6.8 per cent, 14.8 per cent and 5.6 per cent of our total purchases from all origins.

3. Preponderant rôle of Spain

While in 1981 the structure of imports seems better distributed, Spain continues to be the major supplier, with a share equivalent to 71.28 per cent of the total (with a value of D 4,767,000).
