2. Cheese
3. Margarine
4. Preserves (including chutneys and pickles)
5. Vegetables (fresh, chilled or frozen)
6. Ice-cream
7. Fruits (fresh, chilled or frozen)
8. Cigars
9. Snuff
10. Fresh flowers
11. Fresh plants, roots, trees and bulbs (other than for agricultural purposes)
12. Floor tiles and other similar articles
13. Diamond boarts (powder)
14. Domestic furniture and parts thereof (other than beds and spring mattresses of iron and steel)
15. Electric lamps and lanterns (domestic) and parts thereof
16. Chimneys, globes and shades for all types of electric lamps and lanterns
17. Chlorine
18. Waste paper and old paper
19. Wallpaper
20. Calendars
21. Parts of bicycles: Saddle covers, brake blocks, pedal blocks, pedal covers, handle grips, bar covers and stands
22. Waiters, wagons and tea trolleys (household)
23. Bangles and beads
