Addendum

Since March 1965, when document COM.TD/7 was issued, a number of corrections, amendments and additions to the data contained in the document have been notified to the secretariat. These notifications are incorporated in the present document.

The entry " - " for Finland on ex 15.11 Glycerine should be replaced by "R".

Page 17

The entry "*" for Finland on cotton, not carded or combed, 55.02 should be deleted, and the footnote at the bottom of the page shown against "*" should be deleted.
