ACTION BY GOVERNMENTS RELEVANT TO THE PROVISIONS OF PART IV

Addendum

The following notification on the implementation of Part IV has been received from the Government of Denmark and should be included in Annex II of COM.TD/60.

DENMARK

Denmark has continued to comply with the standstill provisions set out in paragraphs 1(b) and (c)(i) of Article XXXVII.

Since 1 January 1967, Denmark has no quantitative import restrictions on products falling within BTN Chapters 25-99.

As regards BTN Chapters 1-24 (apart from certain temperate agricultural products) Denmark maintains quantitative import restrictions for only a few of those products which have been notified as being of export interest to developing countries. The liberalization has been extended on 1 July 1967, 1 January 1968 and 1 July 1968 to cover the following products:

ex 07.02	Asparagus, preserved by freezing
ex 20.02	Asparagus, prepared or preserved otherwise than by vinegar or acetic acid
ex 06.03	Cut flowers and flower buds of a kind suitable for bouquets or for ornamental purposes, dried, dyed, bleached, impregnated or otherwise prepared
ex 07.06	Manioc, arrowroot, sweet potatoes and other similar roots and tubers with high starch or inulin content, fresh or dried, whole or sliced; sago pith (rest of item)

ex	08.08	Elderberries.	fresh

ex 08.11 Elderberries, provisionally preserved

ex 07.01 Peas, fresh or chilled

ex 07.01 Broccoli, fresh or chilled

ex 07.03 Peas, provisionally preserved

ex 07.03 Broccoli, provisionally preserved

ex 16.02 Other prepared or preserved meat or meat offal from animals classified under heading No. 01.06

ex 17.02 Lactose syrup

As indicated in COM.TD/43 of 30 March 1967, some of the Danish offers in the Kennedy Round negotiations on a number of products of export interest to the developing countries were implemented in advance with effect from 1 January 1967. This meant the abolishment of tariffs on bananas; pineapples; cocoa paste (in bulk or in block), cocoa powder, unsweetened; extracts, essences or concentrates of tea; and pre-tanned bovine cattle hides (including buffalo hides) imported by tanneries for subsequent tanning. Moreover the duties were reduced from 10 per cent to 5 per cent on pepper and pimento, put up for retail sale; cinnamon and cinnamon tree flowers, put up for retail sale; rice, except rice in the husk, husked rice and broken rice; finally the duty on chutney was reduced from 18 per cent to 10 per cent.

Lastly Denmark has as from 1 July 1968, accorded duty-free entry of certain handloom cotton textiles provided that certain procedures are complied with. This concession is of special interest to India.
