INFORMATION SUPPLIED BY GOVERNMENTS IN RESPECT
OF RESIDUAL RESTRICTIONS AFFECTING ITEMS NOTIFIED
AS BEING OF EXPORT INTEREST TO LESS-DEVELOPED
COUNTRIES

At the last meeting of the Group on Residual Restrictions, the secretariat was requested to prepare - with the assistance of governments concerned - a working paper, giving details about quotas established in respect of a list of products notified as being of export interest to less-developed countries, and subject to residual restrictions, as well as recent data on production, and imports, together with indications by governments regarding plans for liberalization of imports of these items, and about any target dates for such liberalization.

To comply with this request, the secretariat sent a questionnaire to contracting parties concerned, asking for the relevant statistical data and the other information requested from governments.

The information received to date in response to this questionnaire is reproduced below. Information from other governments will be circulated as soon as it is received.

A copy of the questionnaire, as sent to governments, together with the accompanying letter, is also annexed for information.

COPY OF LETTER SENT ON 1 SEPTEMBER TO DELEGATIONS OF
CONTRACTING PARTIES MAINTAINING RESIDUAL IMPORT RESTRICTIONS
ON PRODUCTS OF EXPORT INTEREST TO LESS-DEVELOPED COUNTRIES

.....

"... I am writing to you in connexion with the recommendation of the Group on Residual Restrictions, endorsed by the Committee on Trade and Development, that discussions be held on a country-by-country basis, with developed contracting parties maintaining restrictions inconsistent with the GATT on products of export interest to less-developed countries (see COM.TD/B/2 and COM.TD/10).

"To facilitate such discussion in the Group on Residual Restrictions, the secretariat was requested to draw up, with the assistance of governments concerned a background paper giving information in respect of the products which are subject to such restrictions. The data and information requested relate to the licensing arrangements applicable to imports from different sources, and to plans or programmes for the liberalization of these items, including any target dates adopted in this regard, and to statistics of production and imports.

"To comply with this request, the secretariat has, as an initial step, selected from the list of products notified by governments as being subject to residual restrictions - as set out in document L/2336 - those products which would seem to correspond to the products notified earlier to Committee III as being of export interest to less-developed countries. The items so selected have been inserted in the questionnaire, three copies of which accompany this letter (see attachment).

"We would be most grateful if you could arrange to have the questionnaire filled in by the competent authorities and to return the completed questionnaire by 28 September, to permit the paper to be finalized in time for the discussion in the Group on Residual Restrictions, scheduled to meet from 18-22 October (see GATT/AIR/485).

"Finally, I would like to point out that there may be some other products of interest to less-developed countries to which restrictions are still applied, but which are not mentioned in the annexed questionnaire. It would be appreciated if relevant information in regard to any such products would also be provided. Attention is drawn in this connexion to document series TN.64(LDC)..."

COFFRE THE QUESTIONNAIRE RELATIF A TRESIDUAL RESTRICTIONS

- The questionnaire is being circulated to facilitate the drawing up of a working paper, requested for the next meeting of the Group on Residual Restrictions (see COM.TD/B/2 and COM.TD/10).
- Information is asked for in respect of items notified earlier as being of export interest to less-developed countries (cf: COM.TD/7, or COM.III/136) and included in the notification by governments of residual restrictions (L/2336, and addenda). The items inserted in column 1, were selected by the secretariat on the basis of these documents, no distinction being made of whether, or not, the restrictions are considered to be consistent with the General Agreement or the Protocols of Provisional Application.¹
- Governments are invited to verify - or, as appropriate, to amend - the list of items shown as being subject to residual restrictions and, in respect of items subject to such restrictions, to complete the questionnaire. It would be helpful if the data could be shown as set out in the suggested notation.
