## ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

## Article 4 Notifications

The Textiles Surveillance Body (TSB) has received from the Government of AUSTRIA a notification of an agreement between Austria and India concerning trade in textiles. This agreement has been notified by Austria under Article 4, paragraph 4, of the Arrangement.

The TSB, pursuant to its procedure regarding bilateral agreements notified under Article 4<sup>1</sup> has examined the relevant documentation. The TSB is circulating the text of this agreement to participating countries in the Arrangement for their information.

Letter No. 1

Vienna, 30 August 1974

Sir,

I have the honour to refer to the negotiations between a delegation of Austria and a delegation of India held in Vienna on 21 June 1974. As a result of these negotiations the following agreement concerning imports of cotton textiles into Austria under the ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES has been reached:

## (1) Import quotas in metric tons for twelve-month period beginning

- (2) Upon presentation of export licences issued by the Indian authorities on the basis of firm contracts for the supply of cotton textiles the competent Austrian authority will licence the corresponding import within a period of three weeks. On application by importers the validity of Austrian licences of six months may be extended four times for an additional period of three months each.
- (3) An undue concentration of imports of cotton textiles from India to Austria as regards articles and/or time shall be avoided. Accordingly, the Government of India will use its influence to achieve this aim.
- (4) Periodic consultations regarding the conduct of exports of cotton textiles from India to Austria will be held if so desired by either party.

Lustria applied unilateral import measures from 1 January 1974 until this bilateral agreement was concluded. See COM.TEX/SB/16 for the levels of restraints.

I should be grateful if you would kindly confirm that this letter sets out correctly the understanding reached between both delegations.
