ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES Notification Under Article 2, paragraphs 2(ii) and 4 Agreement between Norway and the Republic of Korea

Attached is a notification received by the Textiles Surveillance Body (TSB) from Norway concerning an agreement with the Republic of Korea. The TSB noted that there was no specific mention in this agreement of the Article of the Arrangement under which it was concluded. Having due regard to the fact that this agreement would expire at the end of 1974, and bearing in mind the intention of the two parties concerned to conclude a new agreement under Article 4 for the year 1975, the TSB decided to circulate this agreement to the Textiles Committee as an interim arrangement under Article 2, paragraphs 2(ii) and 4 of the Arrangement.

Dear Mr. Choi,

With reference to the agreement reached during the consultations between the Korean and the Norwegian delegations held in Oslo on 24 May 1974, I take pleasure in informing you that the Norwegian authorities are prepared to issue inport licences up to the following amounts for the importation of textile greats shipped from the Republic of Korea from 1 January to 31 December 1974:

Fabrics

\$385,000

Other textile articles and garments

\$415,000 (limited to \$75,000 per item)

It is further the understanding that the Norwegian authorities will issue import licences on the basis of Korean export recommendations stating that the consignments in question have been debited to the agreed limits.

In the event that the Korean authorities do not fully utilize their export quotas, the Norwegian authorities will accept a carry-over not exceeding 30 per cent of the annual quota amounts.

I also take pleasure in informing you that the following import items from the Republic of Korea have been liberalized:

RECORD OF DISCUSSIONS

In the course of the annual trade consultations between the Norwegian and Korean delegations held in Oslo on 24 May 1974, the Korean delegation requested that the Republic of Korea be removed from the list II area, and that the Norwegian Government expedite its liberalization of the importation of Korean goods by reducing the number of items to be covered by the present Arrangement between the Kingdom of Norway and the Republic of Korea, such as BTN Nos. ex 39.02, ex 40.11, 69.11, 69.12, and ex 85.25, listed in Annex A attached to the letter of 24 May 1974 from the chairman of the Norwegian delegation to the chairman of the Korean delegation.

The Norwegian delegation took note of the Korean request and declared its readiness to submit the matter to the Norwegian authorities concerned for further study and to inform the Korean Government of the Norwegian position at the next consultations.

Upon request from the Korean delegation, the Norwegian delegation declared that applications for import licences for Korean goods other than textiles falling within the Norwegian system of quantitative restrictions on imports would be considered favourably within reasonable quantities without however being able to commit themselves to any obligations beforehand.

During the consultations both parties expressed an eager interest in promoting and diversifying trade between the two countries in various fields. They also stressed the mutual interest in exploring the possibilities of economic co-operation in the fields of shipbuilding, ships' gear, oil-drilling equipment and fisheries.
