With reference to paragraph 4 of Article 2 of the Arrangement Regarding International Trade in Textiles (hereinafter referred to as the Arrangement), I have the honour to inform you of the following actions taken by Austria pursuant to this Article.

I. Actions taken to bring the quantitative measures notified to the Textiles Surveillance Body under paragraph 1 of Article 2 in COM.TEX/SB/16 and Corr.1 into conformity with the Arrangement.

1. Bilateral agreements concluded under Article 4 of the Arrangement in the field of cotton textiles.

Liberalization within the framework of GATT has been extended by Austria to the aforementioned countries as of 1 January 1975.

An understanding concerning the trade relations between Austria and Japan which was signed in Vienna on 18 December 1974 provides, <u>inter alia</u>, that in the field of textiles including cotton textiles a solution will be sought in accordance with the provisions of the Arrangement.
