ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Report on Status of Restrictive Measures Under Article 2, Paragraph 4

Note by the Chairman

The TSB has received from the United States a report on the status as at 31 March 1975 of restrictive measures originally notified by it in document COM.TEX/SB/3.

With respect to the negotiations now in progress, the TSB expressed the hope that they would be successfully concluded as soon as practicable.

In view of the request received from the United States, the TSB concurred in an extension of the time-limit in accordance with Article 2, paragraph 2, of the Arrangement. The TSB requested a report from the United States on the progress made within ninety days of the date of the report, i.e. by 30 June 1975.

The TSB is circulating this notification to countries participating in the Arrangement for their information.

Dear Mr. Chairman,

Pursuant to the applicable provisions of Article 2 of the Arrangement Regarding International Trade in Textiles, I am instructed by my Government to inform the Textiles Surveillance Body of the status of efforts as of 21 March 1975 by my Government to comply in full with the requirements of paragraph 2(ii) of Article 2 and Article 4 of the Arrangement.

Attached to this letter is a resumé of the current status of all bilateral agreements previously notified by the Government of the United States of America to the Textiles Surveillance Body under the provisions of paragraph 1 of Article 2 of the Arrangement. As will be noted from the attached resumé, the bilateral agreements in question are broken down into seven categories: listed under (1) are those new bilateral agreements which have been formally concluded under Article 4 and notified to the TSB; reported under (2) are bilateral negotiations which have been completed with memoranda of understanding signed but which await formalization through exchange of Notes; reported under (3) are bilateral agreements presently under active negotiation; under (4) there is a firm schedule for formal negotiation of the remaining agreements in the months of April, May and June of 1975; under (5) and (6) are shown agreements terminated or in process of termination and, under (7) are listed two agreements where consultations to establish mutually acceptable negotiating dates and venues are under way.

It is the intent and expectation of my Government that formal Note exchanges covering those new agreements now covered by signed memoranda of understanding will be effected shortly and that these new agreements vill be notified to the TSB promptly thereafter.

Despite the best efforts of my Government and the governments of our textile trading partners, we have been unable to complete, as had been hoped, the renegotiation of all the bilateral agreements to which the United States is party within the period ending 31 March 1975. The impediments to complete conformance to the terms of the Arrangement have been almost entirely physical, arising from the limited number of competent personnel, both within my Government and within the governments of our trading partners and the resulting difficulties in arranging mutually acceptable negotiating schedules with the large number of trading partners.

In light of the foregoing, my Government finds it necessary to request, under the provisions of paragraph 2(ii) of Article 2 of the Arrangement, the concurrence of the Textiles Surveillance Body for an additional period of time to permit the completion of the remaining firmly scheduled negotiations. The Government of the United States expects all its agreements to be brought into conformity with the provisions of Articles 2 and 4 of the Arrangement by the end of June 1975.
