#### ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

#### Article 4 Notification

#### Agreement Between Norway and the Republic of Korea

The TSB has received from the Government of NORWAY a notification of a bilateral agreement between Norway and Korea concerning trade in textiles. Pursuant to its procedure regarding bilateral agreements, the TSB has examined the relevant documentation and is circulating the Agreement to participating countries for their information. The TSB noted that the Agreement also covered a number of non-textile items which were not relevant for the purposes of the TSB's review. 2

#### Mcmorandum of Understanding

In connexion with the Arrangement agreed upon between the Republic of Korea and the Kingdom of Norway in 1968, the annual consultations under the Arrangement for fixing the quotas for 1975 and extending liberalization of trade between the two countries took place in Seoul from 27 June to 1 July 1975, between the Korean and Norwegian delegations.

From the Norwegian side, it was stressed that special attention has been paid to the needs of the Republic of Korea as a developing nation to expand its exports, and, furthermore, to the necessity of granting special treatment to the Republic of Korea as a new entrant to the Norwegian market.

The list of sensitive items where a real risk of market disruption may exist has been examined. As a result, the two delegations have agreed to transfer the following products from the quantitative restriction list to the automatic license list:

The two delegations have agreed to the following quotas in the period 1 January to 31 December 1975:

Fabrics \$850,000

Other textile articles and garments \$600,000 (limited to \$100,000 per item)

Both parties agreed that the yearly quotas for 1975 satisfy more than the Linimum requirements of the Arrangement Regarding International Trade in Textiles.

It is the understanding that the Norwegian authorities will issue import licenses automatically on the basis of Korean export recommendations stating that the consignments in question have been debited to the agreed limits.

In the event that the Korean authorities do not fully utilize their expert quetas, the Norwegian authorities will accept a carry-over not exceeding 30 per cent of the annual accounts.

Both sides agreed that the following terms should be liberalized:
