ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Articles 7 and 8

Agreement between Sweden and Mauritius

The Textiles Surveillance Body has received from Sweden a notification under Articles 7 and 8 of an agreement concluded with Mauritius. This agreement covers the period 1 November 1977 to 31 December 1978.

This notification has been made in accordance with the decision of the Textiles Committee that agreements concluded with non-participating countries in the Arrangement should be notified.

The TSB is circulating the notification to participating countries for their information.

RECORD OF UNDERSTANDING

During consultations held in Port Louis from 6 to 9 September 1977 regarding imports of certain textile products from Mauritius into Sweden, representatives of the Governments of Mauritius and Sweden agreed as follows:

During the period 1 November 1977 to 31 December 1978, the Government of Sweden will admit imports, through a system of import licences, for deliveries from Mauritius to Sweden of products of Mauritius origin listed in Annex I to this Record of Understanding up to the levels stated in Annex II to this Record. It is understood that imported quantities which are re-exported are not to be debited to this amount.

The Government of Mauritius and the Government of Sweden agree to consult each other, at the request of either, when any problem arises from the implementation of this agreement. The Government of Mauritius and the Government of Sweden agree furthermore to enter into consultations, through diplomatic channels, on the prolongation, modification or termination of this arrangement before the end of the period of agreement.
