ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4:4

Amendment to the Agreement between the United States  
and Romania

The Textiles Surveillance Body has received a notification from the United States of a further amendment to its bilateral agreement with Romania, concluded under Article 4 of the Arrangement<sup>1/</sup>, with respect to wool and man-made fibres.

The TSB, pursuant to its procedure regarding bilateral agreements notified under Article 4<sup>2/</sup>, has examined the relevant documentation and is circulating the text of the notification to the participating countries.

Dear Mr. Fodor,

I refer to the Agreement between the United States of America and the Socialist Republic of Romania Relating to Trade in Wool and Man-Made Fibre Textiles, effected by exchange of notes dated 17 June 1977, as amended (the Agreement), and to consultations held in Washington on 18 July 1979 between representatives of the Government of Romania and representatives of the Government of the United States.

As a result of the request made in your letter of 18 June 1979 and in accordance with the results of the above-mentioned consultations, I propose that paragraph 3(C) of the Agreement be amended to establish a designated consultation level of 150,000 square yards equivalent for category 410, woollen and worsted fabric.

If the foregoing proposal is acceptable to the Government of the Socialist Republic of Romania, this letter and your letter of confirmation on behalf of the Government of the Socialist Republic of Romania shall constitute an amendment to the Agreement, effective on the date of your letter of confirmation.
