Letter to Chairman, TSB from Permanent Delegation of Peru

Geneva, 4 September 1979

Dear Mr. Chairman,

With reference to your kind letter of 10 July 1979 (ref. TS/140-1), I have pleasure in informing you that under the new trade policy introduced this year with a view to eliminating gradually import restrictions and reducing tariffs, the Peruvian Government has enlarged the list of permitted textile imports.

This enlarged list, which is non-discriminatory, is attached hereto; it supplements the list of permitted imports that we communicated to the Textiles Surveillance Body on 31 May 1978 and which was circulated in document COM.TEX/SB/344 dated 21 July 1978.

These notifications will serve as a basis for the annual review to be carried out by the Textiles Surveillance Body under Article 11:11 of the Arrangement Regarding International Trade in Textiles.
