UNITED STATES AND THAILAND AMEND TEXTILE AGREEMENT

The United States and Thailand exchanged letters dated March 21, 1980 and March 27, 1980 to amend the existing bilateral textile agreement. The texts of the letters are as follows:

Dear Mr. Pratoonmas:

I refer to paragraph 4 of the Agreement between the United States of America and the Royal Thai Government relating to Trade in Cotton, Wool and Man-Made Fiber Textiles and Textile Products, with annexes, effected by exchange of notes October 4, 1978, as amended ("the Agreement") and to your recent conversations with my office concerning exports of products in Category 604 from Thailand to the United States.

In accordance with those discussions I propose that Annex C of the Agreement be amended to establish a Designated Consultation Level of 2,000,000 square yards equivalent for Category 604. If this proposal is acceptable to the Royal Thai Government, this letter and your letter of confirmation shall constitute an amendment to the Agreement.
