REPORT TO THE TEXTILES COMMITTEE, JUNE 1980

CATALOGUE OF VARIATIONS FROM ANNEX B

Section I

Introduction

1. At its meeting in December 1979, the Textiles Committee asked the Textiles Surveillance Body to prepare a catalogue of all cases where the provisions of agreements entered into involved variations from the provisions of Annex B of the Arrangement.

2. The present report is submitted in response to this request. The report deals with all the agreements between participants and all amendments thereto notified to the TSB since the coming into force of the Protocol of Extension, i.e. 1 January 1978, and reviewed by it up to 1 June 1980. It is based on the contents of the bilateral agreements in question, as well as information provided by participating countries in response to a circular letter dated 21 February 1980, from the Chairman of the TSB.

3. In considering the implementation of the mandate from the Textiles Committee, the TSB noted from the outset that the process involved in this task would not be the same as that followed by the Body in reviewing the Article 4 notifications submitted to it. In reviewing such notifications, the TSB examines each agreement on overall terms with respect to its conformity with the MFA as extended, rather than assessing separately the specific elements of such agreements in terms of the provisions of Annex B alone. Thus, in presenting the information contained in this report, the TSB notes that it relates to elements which form only a part of such reviews; the TSB reaffirms the findings, observations and recommendations made in the course of its normal review of notifications and subsequently reported to the Textiles Committee.

4. As a first step in the preparation of its work, the TSB decided to compile elements of each bilateral agreement in terms of the extent to which these elements correspond to, or differ from, the specific numerical levels or percentages set out in Annex B for base levels, growth, swing and carryover/carry forward. These numerical levels of percentages are given below:

(a) Base levels:

(i) If computed in terms of past trade, the level is that of the base period as set out in Annex B, paragraph 1.

- (ii) If computed in terms of past restraints the level is that for the immediately preceding twelve-months period increased by not less than 6 per cent.
- (b) Growth: not less than 6 per cent.
- (c) Swing: 7 per cent.
- (d) Carryover/carry forward: 10 per cent, of which carry forward not more than 5 per cent after consultation between the parties concerned.

5. Most agreements notified during the period have been concluded under Article 4^{1/}, and all elements related to these agreements should be considered together and not in isolation from one another. On the other hand, each element of Article 3 agreements should be compared individually with the relevant provisions of Annex B. It follows that a catalogue of variations depends on the standpoint taken, and might be drawn up either on the basis of Annex B, as such, without any reference to the other elements of the MFA, or by taking Annex B in the light of the provisions of the MFA as a whole, and in particular of Article 4.

6. Such different approaches would lead to different definitions of what constitutes a variation. In these circumstances, the TSB felt that it would not be appropriate to adopt either of these approaches to the exclusion of the other. The TSB also noted that the definition of variations was further

^{1/} Paragraph 3 of Article 4 reads as follows: "Bilateral agreements maintained under this Article shall, on overall terms, including base levels and growth rate, be more liberal than measures provided for in Article 3 of this Arrangement. Such bilateral agreements shall be designed and administered to facilitate the export in full of the levels provided for under such agreements and shall include provisions assuring substantial flexibility for the conduct of trade thereunder, consistent with the need for orderly expansion of such trade and conditions in the domestic market of the importing country concerned. Such provisions should encompass areas of base levels, growth, recognition of increasing interchangeability of natural, artificial and synthetic fibres, carry forward, carryover, transfers from one product grouping to another and such other arrangements as may be mutually satisfactory to the parties to such bilateral agreements".

complicated by the existence of certain specific provisions in Annex B relating to growth and swing at rates lower than the numerical levels set out in paragraph 4 above.¹

7. Given these conceptual problems, the TSB agreed that the best course of action would be for it to submit to the Committee a compilation of all the numerical levels or percentages with respect to base levels, growth, swing, carryover/carry forward, contained in the agreements between participants which had been notified to it, be they higher, equal to or lower than those set out in paragraph 4 above. This information is contained in Section II of this report in the form of tables, one for each bilateral agreement between MFA participants. The tables are accompanied by country notes on particular aspects of certain agreements as these relate to specific provisions of Annex B.

8. With respect to these tables, the TSB noted that the categories or groups used by the importing countries are not identical; that the extent of product coverage varies considerably among importing countries; and that the data as presented do not show, in either quantitative or qualitative terms, the share of total imports represented by products under restraint. For these reasons, and the considerations outlined in paragraphs 5 and 6 above, the data presented in the tables do not lend themselves to a direct comparison of the agreements concerned.

9. The tables in Section II reflect the situation with respect to the multi-year agreements as it existed on 1 June 1980. These tables when read in conjunction with the country notes which accompany them, and in the light of the considerations cited above, provide all of the elements for a catalogue of variations from the provisions of Annex B.

¹The relevant words of paragraphs 2 and 5 of Annex B read as follows: "...In exceptional cases where there are clear grounds for holding that the situation of market disruption will recur if the above growth rate is implemented, a lower positive growth rate may be decided upon after consultation with the exporting country or countries concerned. In exceptional cases where participating importing countries have small markets, an exceptionally high level of imports and a correspondingly low level of domestic production and where the implementation of the above growth rate would cause damage to those countries' minimum viable production, a lower positive growth rate may be decided upon after consultation with the exporting country or countries concerned".

"...the agreed level for any one product may be exceeded by 7 per cent save in exceptionally and sparingly used circumstances where a lower percentage may be justified in which case that lower percentage shall be not less than 5 per cent".

Country Note

Austria has negotiated ten selective bilateral agreements with five exporting participants. Four of these agreements were concluded under Article 3 and the rest under Article 4. Product coverage in these agreements varied from one item in three agreements; two items in four agreements; three items in two agreements to seven items in one agreement. Five agreements have expired. Base levels were calculated in accordance with paragraph 1 of Annex B for new items brought under restraint and in accordance with paragraph 2 of Annex B for items previously under restraint.

CANADA

Country Note

1. The tables which follow present data on selective Article 4 agreements negotiated by Canada with ten MFA participants and covered by TSB reviews up to 1 June 1980.

Base levels

2. The negotiations which Canada conducted with a number of trading partners were extended over a considerable period of time and did not involve the formal establishment of a base period in the sense of Annex B or the calculation of base levels on that basis. The levels achieved in the agreements were negotiated levels based upon historic performance over a number of years. In addition, as clothing categories were developed during the negotiations on the basis of the particular interests of both parties, these categories did not always compare directly with historical data. In some cases, it was possible to deduce comparisons with what would have been the base levels as set out in Annex B. To facilitate the examination of base levels in certain cases, however, comparisons have been made with actual trade performance data for calendar year 1978 - the period immediately preceding the first year of the agreement.

Flexibility

3. In many Canadian agreements, traditional swing has been expanded by the provision of additional flexibility through the conversion of adult garments quota to that of children and infants on a ratio of three adult units to five units children and infants' wear. In addition, flexibility has been enhanced in many categories by the provision of full-fibre interchangeability.

Country Note

1. The Community has negotiated twenty-one¹ agreements with textiles exporting participants under Article 4 of the Arrangement. all being comprehensive agreements covering 114 categories. The data presented under Section III² of this report concerns those categories which were subject to restraint in these agreements and covered by TSB reviews up to 1 June 1980.

Base levels

2. The negotiations between the EEC and its trading partners conducted in late 1977. were based on a new system of categorization providing a unified series of categories for the first time for the Community as a whole, as well as for all supplying countries. The new system had to take account of changes in description of individual nomenclature positions as well as of the need for regrouping of products into a comprehensive system.

3. With the exception of a small number of categories it was found that no adequate comparison could be made between the old and the new categories. Also, at the time of the negotiations, statistics relating to the Annex B roll-back period were not available for the Community as a whole. In the circumstances. the Community did not use as its basis for negotiating new levels either previous restraint levels or the roll-back levels as set out in Annex B; rather, the Community took imports during 1976 as the reference for negotiating 1978 restraint levels.

4. The TSB therefore was of the view that:

- (i) whereas no precise comparison with the relevant element of Annex B would be possible;
- (ii) nonetheless, reference to 1976 trade was the most practical means to provide a comparison with new restraint levels;
- (iii) this comparison gives a useful overall picture of quotas relative to past trade.

¹In addition consultation agreements without any restraint limits have been concluded with four participants. These are not contained in the attached tables.

²Section III includes information relating only to agreements with countries which are at present parties to the MFA.

5. On the basis of information submitted by the Community and using later reconstructions of 1976 and 1977 data, it is apparent that in some cases, the 1978 restraint levels involved reductions on both 1976 trade and 1977 restraint levels. In most cases, however, the 1978 levels constituted increases (and, in some cases, substantial increases) over 1976 trade levels or what might have been the roll-back levels.

Country Note

1. Finland has negotiated selective agreements with five exporting participants under Article 4 of the Arrangement, with product coverage varying from one to four products. These agreements were concluded having due regard to the provisions relating to the minimum viable production as set out in Article 1:2 and in paragraph 2 of Annex B, and consequently provide for positive growth rates lower than the growth of not less than 6 per cent.

Base levels

2. In four agreements of the total of five, base levels have been negotiated on the basis of roll-back levels. With one exception concerning one category all these agreements provide for higher or considerably higher base levels than those of the roll-back period. In one agreement with the major supplier (Hong Kong) in the categories covered, reductions have been negotiated in relation to past restraint levels in two categories and in relation to the roll-back level in one category.

Sweden has negotiated selective¹ agreements with ten exporting participants under Article 4 of the MFA. These agreements have been entered into with due regard to the provisions concerning minimum viable production as set out in Article 1:2 and in paragraph 2 of Annex B. These agreements provide for growth rates considerably lower than 6 per cent. Generally, Swedish agreements do not contain swing, carryover and carry forward. In some cases reductions in base levels or previous restraint levels have been negotiated.

UNITED STATES

Country Note

1. The United States currently has in effect Article 4 bilateral agreements with eighteen MFA participants. Of these, the agreements negotiated with fifteen countries are comprehensive (covering 104 categories via specific limits or different types of consultations mechanisms); agreements with two countries cover only cotton products; the agreement with Yugoslavia is selective, and covers only two wool/man-made fibre categories.

Base levels

2. In 1977, the United States modified the textile and apparel category system used in bilateral agreements, reducing total number of categories from 126 to 104, and also regrouping a wide variety of individual line items, particularly in the case of apparel.

3. During the latter part of 1977 and early 1978, the United States Government worked with each of its trading partners to develop a mutually agreed upon "translation" from the old (pre-1978) category system to the new system in terms of "calculated" or "constructed" trade and restraint levels for 1976 and 1977 for the new categories established in 1978. While in many cases it was not possible to derive a figure by simply applying a mathematical formula, it was possible in each instance to construct a mutually satisfactory solution.

4. The data used in the tables which follow are based upon the data developed on a bilateral basis with each trading partner as outlined above.

Swing

5. In most agreements, swing into individual categories is not required to be taken solely from other categories under restraint, but can also be taken from non-restrained "basket" items - a provision which makes such swing tantamount to one-time growth for any given agreement year. In some instances "internal swing" up to levels of 100 per cent is also provided in the form of a "shift" between or among merged categories.
