## ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4:4

Amendments to the Bilateral Agreement 1/between the United States and Thailand—

The Textiles Sureviellance Body has received from the United States notifications of four amendments to its bilateral agreement with Thailand, relating to:

- (a) an increase in the consultation level for Category 345 for the 1982 agreement year;
- (b) the creation of a new merged fabric category and the consequent modification of a specific limit and establishment of a new consultation level for 1982;
- (c) the six-month extension of the agreement;
- (d) the further modification of the consultation level for Category 320.

The TSB, pursuant to its procedures regarding bilateral agreements notified under Article  $42^{\prime}$ , has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

The original agreement and previous amendments are found in COM.TEX/SB/411, 412, 473, 496, 568, 667 and 751.

Dear Mrs. Oranuj:

I am writing with reference to paragraph 4 of the agreement between the United States and Thailand relating to trade in cotton, wool and man-made fiber textiles and textile products, with annexes, effected by exchange of notes on October 4, 1978, as amended ("The Agreement") and to discussions between representatives of our two governments concerning exports from Thailand to the United States of products classified in textile Category 320 (other cotton fabrics, N.K.).

On behalf of my government, I would like to propose that:

- 1. For purposes of the agreement, Category 315 and the items covered under TSUSA No. 326.0092 in Category 320 shall-be merged and treated as a single category;
- 2. Annex B of the agreement shall be amended to establish a specific limit for this category as follows:

Category	Period	Level
315 plus TSUSA No. 326.0092	1/1/82 - 12/31/82	15,760,000 SYD

- 3. The specific limit provided for Category 315 plus TSUSA No. 325.0092 may be exceeded by not more than 6 percent (swing), provided that the amount of the increase is compensated for by an equivalent square yard equivalent decrease in the apparel limit;
- 4. Carryforward and carryover shall not be applicable to Category 315 plus TSUSA No. 325.0092;

5. Annex C of the agreement shall be amended to delete - Categories 315 and 320 and to create the following new category:

320 (excluding TSUSA No	. 325.0052)	1,530,000 SYB

If the above proposal is acceptable to your government, this letter and your letter of confirmation on behalf of your government shall constitute an amendment to the agreement.
