ESTABLISHMENT OF A REGULAR REPORTING SCHEME OF TEXTILE AND APPAREL STATISTICS

at its second meeting held on 18 19 December 1974 the Textiles Committee approved the recommendations put forward in the report of the Technical Sub-Group on Textile Documentation (COM.TEX/3), concerning the establishment of a regular reporting scheme of textile and apparel statistics.

The text of these recommendations, contained in paragraphs 14 and 15 of that report is as follows:

"14. The Technical Sub Group on Textile Documentation recommends to the Textiles Committee that it urge all parties to the arrangement to report to the secretariat:

- (i) Statistics on foreign trade in all textiles and clothing of cotton, wool and man made fibre, on magnetic tape, in the 5 digit detail of SITC/Rev.2, as soon as possible, and of SITC/Rev.1 in the meantime, or in equivalents of these nomenclatures in terms of BTN or national classifications, by origin and destination, as far as possible quarterly, as from 1972;
- (ii) Production statistics for the representative product groups, both quarterly and annually; and
- (iii) Separately for the textile and apparel industry, data on value added by manufacturing (annually); investment, distinguishing the outlay for plant and for machinery (annually); total employment, production workers and average hours worked per week per worker (quarterly).
- 15. The Sub-Group understands that not all statistical services possess all the data in the required detail or periodicity. All parties to the Agreement should report to the full extent of their present ability and, bearing in mind the importance of reciprocity, should undertake all the effort needed to bring their reporting in line with that of the other countries. It recommends that the statistical reporting scheme be re-examined after two years of operation, with the view of assessing its adequacy and the progress made towards better comparability of the data submitted."

Accordingly, parties to the Arrangement are invited to submit to the secretariat the data described in the accompanying questionnaires. These questionnaires refer to I: Foreign Trade in Textiles and Apparel; II: Production of Textiles and Apparel, and III: Industry Statistics for the Textile and Apparel Industries.

The questionnaires refer in general to the period from 1972 to the end of 1974 and relate to the initial information necessary to establish the scheme of regular statistical reporting. To the extent possible, parties to the Arrangement are asked to submit the required statistics to the full extent of their present ability, by 30 June 1975. In this regard it would be appreciated if attention could be given to submitting the information relating to the definitions and methods used in collecting the data to enable the secretariat to assess the present degree of comparability on an international basis.

Since it would be desirable that the compilation of foreign trade statistics form a part of current national statistical programmes, regular requests for magnetic tape copies will not be made. Parties to the Arrangement should submit the required data as soon as possible after the end of the quarter in accordance with their present abilities.

With regard to quarterly production and employment statistics, regular questionnaires will be issued. These questionnaires should be filled in and submitted as soon as possible but not later than four months after the end of the quarter under review. In this regard, tables on production and employment for the quarter ending 31 March 1975, are contained in questionnaires II and III.

Annual data on production, value added by manufacturing and investment will be requested as appropriate. 1972 and 1973 data are contained in questionnaires II and III.

Where compilation of final statistics requires a longer period than indicated, it would be appreciated if every effort could be made to supply provisional estimates before the definitive results are available.

QUESTIONNAIRE I

Foreign Trade in Textiles and Apparal

1. The Textiles Committee at its meeting of 18 and 19 December 1974 approved the following recommendation of the Technical Sub-Group on Textile Documentation concerning the collection of foreign trade statistics:

"Foreign trade statistics for all textiles and clothing of cotton, wool and man-made fibres should be supplied on magnetic tape in the 5-digit. detail of SITC, Rev. 2 as soon as this classification is implemented at the national level, and of SITC, Rev. 1 in the meantime, or in equivalents of those nomenclatures in terms of BTN or national classifications, by origin and destination, as far as possible, quarterly as from 1972."

- 2. Should it facilitate the work of national statistical services, or speed up the submission, data in the detail currently complied by national customs or statistical administrations covering all products classified in SITC, Rev. 2, divisions 65 and 84 could alternatively be supplied.
- 3. SITC Revised refers to the United Nations Standard International Trade Classification published in statistical papers, Series M, No. 34, United Nations, New York 1961.
- 4. SITC, Rev. 2, refers to the United Nations Standard International Trade Classification which incorporates revisions of the present SITC Revised mentioned above. The SITC, Rev. 2 is comparable with the SITC Revised, although not always at the 5-digit level, and it achieves a one-to-one correlation with the Brussels Nomenclature (BTN). Annex I contains the BTN headings and sub-headings pertaining to textiles and apparel together with the corresponding SITC, Rev. 2 numbers. This list incorporates a number of modifications carried out in general to achieve the one-to-one correlation between the SITC, Rev. 2 and the BTN. It supersedes therefore the extract relevant to textiles and apparel of the provisional SITC, Rev. 2 reproduced in COM.TEX/W/15 and circulated to members of the Textiles Committee in December 1974. A list of these modifications in terms of the SITC Rev. 2 is contained in Annex II.
- 5. To the extent possible, data should be supplied in the 5-digit level of the SITC, Nev. 2, or in the equivalent of that classification in terms of the BTN. More detailed data may be submitted if more convenient for the respondent.
- 6. Data may, however, be supplied in the 5-digit level of the SITC Revised or in the equivalent of that classification in terms of the BTN until such time as the SITC, Rev. 2 is utilized at the national level.

- 7. Alternatively, data may be supplied in terms of national classifications. In this case the parties concerned are requested to provide a concordance with either the SITC or the BTN where:
 - (a) the national classification is neither SITC nor BTN based; or
 - (b) the data is supplied in <u>national</u> sub-divisions of the 4-digit BTN.
- 8. To the extent possible the data should be submitted in the full detail of countries of origin and destination, together with details of the country codes used.
- 9. Parties are asked to provide data quarterly as far as possible for all years beginning with 1972. Data may be provided either cumulatively or non-cumulatively, together with details of the methods by which corrections for earlier periods are taken into account.
- 10. If quantities are already collected at the national level in two units of measurement (e.g., surface and weight for fabrics, number of pieces and weight for apparel) it would be appreciated if quantities were reported in both units. If fabrics are reported in linear units only, conversion factors to weight or surface units are also requested. Furthermore, if apparel is reported in different units of measurement, any available data or estimates in weight would be appreciated.
- 11. Value may be reported in either national currency or United States dollars. If the latter method is used, please indicate the rates at which conversion is carried out.
- 12. Import data should, if possible, relate to special or retained imports. Should this not be possible, quantity and value of re-exports should be given separately for each commodity group where re-exports are of any significance. In all cases the system of reporting for instance, general or special trade) should be clearly indicated.
- 13. The data should, to the extent possible, be supplied on magnetic tape, together with details of the tape layout. Parties to the Arrangement not at present having computer facilities are requested to report in the form at present used by their national statistical offices. In such cases, data at the 5-digit SITC level or its equivalent, and aggregates at the sub-group (4-digit), group (3-digit) and division (2-digit) level in the full detail of origin and destination should be supplied.
- 14. The requested information should be supplied as soon as possibly convenient for national statistical services, but in any case, not later than 30 June 1975. To the extent possible, priority should be given to reporting data for the most recent quarters, especially 1974 and 1973.

QUESTIONNAIRE II

Production of Textiles and Apparel

- 1. This questionnaire contains five tables pertaining to production statistics for the representative product groups approved by the Textiles Committee in December 1974. Table 1 refers to annual figures for 1972 and 1973, and Tables 2 to 5 refer to quarterly figures for the years 1972, 1973, 1974 and the first quarter of 1975.
- 2. As national statistical programmes differ from country to country, parties to the Arrangement are asked to specify the definitions and methods used in collecting production statistics.

In this regard parties are asked to indicate whether:

- (i) the production figures refer to output, manufacturers' sales or shipments, etc., and to provide in each case a definition of the measure used;
- (ii) the production statistics are collected on a commodity basis, i.e., irrespective of the producing sector and the degree of integration of the production unit concerned, or on an industry basis. If the latter method is used, parties are asked to provide, if possible, estimates for production outside the industry;
- (iii) coverage is extended to all firms, or whether a lower limit is applied. In the latter case, parties are asked to specify the lower limit in force.
- 3. Where possible, parties are asked to report in full detail of the product list. However, where difficulties arise in distinguishing products of various processing techniques (e.g., woven/knitted apparel, woollen/worsted yarns and fabrics, etc.), such product groups may be merged. In such cases, any available estimates of the relative importance of the products of different processing techniques contained within such product groups would be appreciated.
- 4. In order to avoid double counting, production figures should refer, where possible, to the following:
 - (a) Fibres (man-made) not carded or combed or otherwise prepared for spinning;
 - (b) Tops first combing only;

- (c) Yarns single yarn, including continuous filament yarn actually spun or extruded, excluding ply, twist or finished yarns;
- (d) Fabrics loomstate fabrics.

If the information is not available in this form, available data approaching this concept may be supplied, together with an indication of the method by which it is calculated.

- 5. Fabrics should, as far as possible, refer to broad woven fabrics. Fabrics for blankets or for simple making-up should be included, but made-up blankets and simple made-up articles should be excluded.
- 6. If data regarding woven pile and chemille fabrics are not available separately, parties are asked to indicate whether they are included under woven fabrics of wool, cotton and man-made fibres where relevant.
- 7. Undergarments for men, boys, women, girls and infants should exclude shirts and blouses.
- 8. Quantities should be expressed in units normally reported. However, when different units are specified for various products, e.g., fabrics and clothing, alternative units should be given if possible.

Industry Statistics for the Textile and Apparel Industries

- 1. This questionnaire contains five tables pertaining to statistics relating to the general state of the textile and apparel industries as approved by the Textiles Committee in December 1974. Table 1 refers to value added by manufacturing and investment for the years 1972 and 1973, and Tables 2 to 5 refer to quarterly employment statistics for 1972, 1973, 1974 and the first quarter of 1975.
- 2. The Textile Industry and the Apparel Industry should, as far as possible, refer to major Group 321, the manufacture of textiles (including spinning, weaving and finishing, the manufacture of made-up textile goods except weaving apparel, knitting mills, the manufacture of carpets and rugs, cordage rope and twine industries, and the manufacture of textiles not elsewhere classified), and Group 322, the manufacture of wearing apparel, except footwear, of the United Nations International Standard Industrial Classification of all Economic Activities (ISIC), Rev. 2, 1968.
- 3. Value added by manufacturing should, as far as possible, be defined according to the "national accounting" concept or the "census" concept and be either in approximate factor values (factor cost) or producers' values (market prices).
- 4. Investment should, as far as possible, refer to gross fixed capital expenditure at current prices (defined as the current value of purchases and own account construction of fixed assets less the value of corresponding sales), or total new gross fixed investment at current prices (excluding repairs and maintenance).
- 5. Total number of employees should, as far as possible, refer to all persons engaged. Please indicate if working proprietors, active business partners, unpaid family workers and homeworkers are included.
- 6. Production workers should, as far as possible, refer to wage earners directly engaged in production and related activities of the establishment. If clerical or working supervisory personnel are included, please specify.
- 7. Please indicate whether number of employees and number of production workers refer to quarterly averages, the number at the end of the period, etc.
- 8. Where national statistical offices collect the above information on a different basis, parties are asked to provide the available information, together with definitions of the measures used.
