# UNITED STATES GOVERNMENT ACTIONS IN IMPLEMENTATION OF THE LONG-TERM ARRANGEMENT REGARDING INTERNATIONAL TRADE IN COTTON TEXTILES

Renewal of restraints:

#### ARGENTINA

"This is to inform you that on 18 August 1964, by diplomatic note, the United States Government informed the Government of Argentina that it was renewing the restraint on Category 1 yarn for one year commencing 3 September 1964, at a level of 420,000 pounds. In accordance with the provisions of Annex B, paragraph 2 of the Long-Term Arrangement regarding Trade in Cotton Textiles, the renewal was made with the addition of a growth factor of 5 per cent."

#### KOREA

"This is to inform you that on 27 August 1964, by diplomatic note, the United States Government informed the Government of Korea that it was renewing restraints as follows:

Category	Restraint Level	Effective Date
46	4,000 dozen	30 August 1964
60	3,150 dozen	30 August 1964
63 (T.S.U.S.A. Nos. 380.3990 and 382.3390 only)	15,750 pounds	30 August 1964

In accordance with the provisions of Annex B, paragraph 2, of the Long-Term Arrangement, the renewal levels for Categories 60 and the restrained subcategories of 63 include a 5 per cent increase over the previous year's ceilings; the renewal levels for Category 46 are without a percentage increase because of the severe disruption of the United States market for cotton textiles in this category."

#### POLAND

"This is to inform you that on 19 August 1964, the United States Government informed the Government of Poland that it was renewing the restraint on Category 35 at a level of 75,600 pieces for the twelve months from 30 August 1964. In accordance with the provisions of Annex B, paragraph 2 of the Long-Term Arrangement, the renewal level for Category 35 includes a 5 per cent increase over the previous year's ceiling."
