LONG-TERM ARRANGEMENT REGARDING INTERNATIONAL TRADE IN COTTON TEXTILES

Information Transmitted by Finland

The attached information relating to quotas and import restrictions on cotton textiles has been transmitted by the delegation of Finland.

A. (1) Restrictions and quotas effective as of 1 October 1964 are listed in the Amnex.

Of the participating countries Czechoslovakia, Greece, Poland and Turkey are subject to bilateral treatment and imports from these countries are subject to licensing as provided for in the quotas of the appropriate bilateral agreement. Imports from Cuba, Israel and the United Arab Republic are subject to individual licensing. Multilateral treatment is applied to the rest of the participating countries.

(ii) The imports of cotton textiles listed below were liberalized as from 1 January 1964, provided that the country of origin and purchase benefits of the multilateral treatment.
