<u>CUANTITATIVE PESTRICTIONS ON -EMPORTS OF COTTON</u> <u>TEXTILES AND ITS REASONS</u>

I. In 1945, Kořeá's demand for clothing was substantially met with governmental and civilian aids from the United States, which included cotton textiles and other apparel goods. Until 1950 when the Korean War broke out, Korea continued to belong to the group of countries whose demand for cotton supply had basically depended upon foreign imports.

During the Korean War and post-war period, the volume of imports of cotton textile goods was sharply expanded. At that time, such imports were generally covered by the financial assistance of the United Nations Civil Assistance Command (UNCAC). In the meantime, most of domestic mills were under reconstruction and rehabilitation, and they started to produce sufficient cotton materials, in quantity and quality, to meet domestic demand.

II. The measures taken by the Government since 1954 are as follows:

- (a) in December 1954 cotton fabrics constructed with above 30 counts of yarns were permitted to be imported only with export earnings;
- (b) in June 1956 imports of cotton yarn below 40 counts were restricted;
- (c) in June 1956 cotton yarn imports were totally prohibited by law, while fabrics were permitted to be imported up to 1 million yards, and
- (d) since December 1956 imports of both cotton yarn and cloth have been totally prohibited by law.

III. Import policies as stated above on cotton textiles have been mainly based upon the following reasons:

- (a) raw cotton supplies have been rather smooth due to the aids of the United States under its support programmes and, particularly after 1956, under its Public Law 480;
- (b) the Government has been compelled to take the restrictive measures
 on importation of cotton textiles in order to improve its balance of payments.
