Basic Statistics on Cotton Textiles

1. The attached forms request data on trade and production¹ for the third quarter of 1964. Space is also provided for data relating to the second quarter of 1964, but only revisions of figures already submitted in connexion with COT/W/26 should be indicated therein. Participating countries are requested not to include figures for the second quarter if they have no revisions to communicate.
2. It will greatly facilitate the work of the secretariat if all participating countries, when preparing their submissions, will make use of the standard forms supplied. Additional copies can be obtained on request. Completed forms should be returned as soon as possible, and in any case not later than 1 March 1965.
3. There are still some participating countries which have not yet responded to COT/W/26 or to previous questionnaires, and these countries are urged to do so as soon as possible.

¹ Data on consumption will be requested once a year.

COTTON TEXTILES COMMITTEE

Statistics on Foreign Trade in and Production of Cotton Textiles

Quarterly Submissions

Statistical information on cotton textiles is required by the Cotton Textiles Committee for the discharge of its functions. Participating countries are therefore requested in accordance with Article 8 of the Long-Term Arrangement Regarding International Trade in Cotton Textiles to complete the attached enquiry forms and to return them to the secretariat as soon as possible. Where necessary, data submitted in earlier replies should be revised.

According to Article 9 of the Arrangement, the expression "cotton textiles" includes yarns, piece-goods, made-up articles, garments, and other textile manufactured products in which cotton represents more than 50 per cent (by weight) of the fibre content, with the exception of hand-loom fabrics of the cottage industry. Should the data reported not comply with these specifications, detailed definitions should be supplied.

In order to distinguish the various groups of cotton textiles on which data are required, references are made on pages 4 and 23 to the United Nations Standard International Trade Classification, Revised (SITC) and to the Tariff Nomenclature of the Customs Co-operation Council (BTN). If these definitions are not followed, the definitions used should be specified.

Quantities and values should, if possible, be submitted in metric tons (without decimals) and thousand United States dollars. In all cases, the unit used should be specified. Where units of quantity other than weight, such as length, surface measurements and numbers, are applied, a factor for conversion into weight should be suggested. It should be indicated whether the trade values reported are at f.o.b. or c.i.f. prices.

Import data should, if possible, relate to retained imports. Should this not be possible, quantity and value of re-exports should be given separately for each commodity group reported where re-exports are of any significance. In all cases the system of reporting (for instance, general or special trade) should be clearly indicated.

In the analysis by provenance and destination all countries which are party to the Long-Term Arrangement should be shown separately. As regards trade with "other countries", investigation has shown that it would be difficult to establish a standard cut-off point to be applied by all participating countries.

Data should be supplied for all countries listed in the enquiry forms as well as for up to six other trading partners considered by each participating country to be of importance to its trade. These additional countries should as far as possible be the same from one submission to the next.

The production data should include yarn and fabrics of cotton made in the cotton as well as in the other sectors of the textile industries. In order to avoid double counting, the figures for yarn should represent single yarn; those on fabrics should relate to fabrics at loom stage.
