Basic Statistics on Cotton Textiles

1. The attached forms request data on trade, production and consumption for the year 1964 and, in the case of production and trade, separately for the four quarters of the year. Figures for the first three quarters were requested in documents COT/W/25, COT/W/26 and COT/W/44; they have, in the case of most participating countries, been submitted. It would, however, be useful if they could be repeated, with any necessary revisions, in the attached forms to ensure that, with the addition of data for the fourth quarter of 1964, quarterly figures add up to the annual totals indicated.
2. Since it is the intention of the secretariat to circulate for each participating country a complete series of statistics for the period 1961-1964, it is important that opportunity should be taken to revise, where necessary, figures previously submitted for the years 1961 to 1963, and to complete, if possible, any series where data are lacking.¹ In this connexion, every participating country is requested to examine attentively the COT/STAT/- documents already circulated relating to its own statistics, and to advise the secretariat of any changes, either in figures or notes, which it considers desirable.
3. It will greatly facilitate the work of the secretariat if all participating countries, when preparing their submissions, will make use of the standard forms supplied. Additional copies can be obtained on request. Completed forms should be returned as soon as possible but in no case later than 1 June 1965. In view of the detailed analysis of development in production and trade in cotton textiles which the secretariat has embarked on in accordance with the decision of the Cotton Textiles Committee it is particularly important that this deadline is maintained.

¹Trade figures relating to the participating countries which have adhered to the Long-Term Arrangement only during the past year, i.e., Finland, the Republic of Korea and Turkey, should be provided if trade with these countries was not identified in earlier submissions.

ANNEXCOTTON TEXTILES COMMITTEEStatistics on Foreign Trade in and Production and
Consumption of Cotton TextilesYearly Submissions

Statistical information on cotton textiles is required by the Cotton Textiles Committee for the discharge of its functions. Participating countries are therefore requested in accordance with Article 8 of the Long-Term Arrangement Regarding International Trade in Cotton Textiles to complete the attached enquiry forms and to return them to the secretariat as soon as possible. Where necessary, data submitted in earlier replies should be revised.

According to Article 9 of the Arrangement, the expression "cotton textiles" includes yarns, piece-goods, made-up articles, garments, and other textile manufactured products in which cotton represents more than 50 per cent (by weight) of the fibre content, with the exception of hand-loom fabrics of the cottage industry. Should the data reported not comply with these specifications, detailed definitions should be supplied.

In order to distinguish the various groups of cotton textiles on which data are required, references are made on pages 3 and 17 to the United Nations Standard International Trade Classification, Revised (SITC) and to the Tariff Nomenclature of the Customs Co-operation Council (BTN). If these definitions are not followed, the definitions used should be specified.

Quantities and values should, if possible, be submitted in metric tons (without decimals) and thousand United States dollars. In all cases, the unit used should be specified. Where units of quantity other than weight, such as length, surface measurements and numbers, are applied, a factor for conversion into weight should be suggested. It should be indicated whether the trade values reported are at f.o.b. or c.i.f. prices.

Import data should, if possible, relate to retained imports. Should this not be possible, quantity and value of re-exports should be given separately for each commodity group reported where re-exports are of any significance. In all cases the system of reporting (for instance, general or special trade) should be clearly indicated.

In the analysis by provenance and destination all countries which are party to the Long-Term Arrangement should be shown separately. Data should, therefore, be supplied for all countries listed in the enquiry forms as well as for up to six other trading partners considered by each participating country to be of importance to its trade. These additional countries should, as far as possible, be the same from one submission to the next.

The production data should include yarn and fabrics of cotton made in the cotton as well as in the other sectors of the textile industries. In order to avoid double counting, the figures for yarn should represent single yarn; those on fabrics should relate to fabrics at loom stage.
