ITALIAN IMPORT RESTRICTIONS

Liberalization of Imports from the Dollar Area

1. By letter dated 7 July 1960, the Government of Italy has transmitted:

- (a) a list of products which have been liberalized by Ministerial Decree of 1 June 1960 when imported into Italy from the dollar area; and
- (b) a list of products, the import of which remain subject to individual authorization when originating in countries which are contracting parties to the General Agreement. This list does not apply to imports from Finland, Japan and Israel for which there are separate lists, or from Czechoslovakia and other State-trading countries.

The items marked by an asterisk (*) are under Ministerial licence when imported from countries of the dollar area, countries of the OEEC, Australia, Burma, Ceylon, Ghana, India, Indonesia, the Federation of Malaya, New Zealand, Pakistan, the Federation of Rhodesia and Nyasaland and the Union of South Africa.
