Addendum

Amendments to Draft Schedule

Following the adoption by South Africa on 1 January 1965 of the Brussels Tariff Nomenclature, the delegation of South Africa presented for certification by the CONTRACTING PARTIES a draft new Schedule XVIII - South Africa transposed into the Brussels Nomenclature. This draft Schedule was circulated to the contracting parties in document L/2748 of 20 February 1967.

A first list of amendments was circulated in document L/3044, dated 26 July 1968.

The delegation of South Africa has now transmitted to the secretariat the following second list of amendments to the draft Schedule.

The amendments and additions appearing in the following list should be effected:

(a) Sub-items ex 20.06 should be substituted for the previous sub-item ex 20.06 -

"G(47) Tamarinds 30 per cent or ALA, BX" 125 cents per 100 lb.

(b) Tariff items and sub-items -
