## IMPORT RESTRICTIONS OF PERU

The Government of Peru has submitted the following text of Supreme Decree No.202-68-HC of 24 June 1968<sup>1</sup>, which contains provisions concerning the temporary prohibition of certain imports until 31 March 1969. The list of imports that have been prohibited, and the articles of the Decree immediately relevant to this suspension, are as follows.

### TITLE III

#### MEASURES TO STRENGTHEN THE BALANCE OF PAYMENTS AND TO REDUCE THE COST OF LIVING

Article 15 - From the date of entry into force of the present Supreme Decree until 31 March 1969, all imports of the following articles shall be prohibited:

Article 16 - Any infringement of the prohibitions contained in Article 15 of this Decree shall be punishable by confiscation of the articles concerned, without prejudice to the other sanctions provided for in Law No. 16185 and in the implementing regulations contained in Supreme Decree 408-H, of 2 December 1966.

Article 17 - For the duration of the period of prohibition mentioned in Article 15 of this Decree, consular officials in foreign countries shall not process invoices in respect of goods mentioned in that Article.
