NOTIFICATIONS OF IMPORT RESTRICTIONS APPLIED INCONSISTENTLY WITH THE PROVISIONS OF GATT AND NOT COVERED BY WAIVERS

- AUSTRIA¹

The following revised notification received from the corresentative of Austria shows the tariff items still under quantitative restriction as from 9 July 1969 when imported into Austria from GATT countries to which Austria has contractual obligations. This notification reflects the liberalization vis-à-vis GATT countries of imports of dead poultry (BTN 02.02) with effect from 9 July 1969.

1. Products falling under the Austrian Law on Marketing of Agricultural Products are marked by an asterisk. The Austrial Government is prepared to make known its opinion on the extent to which the restrictions relating to these products are permitted by virtue of the terms of the Torquay Protocol to the General Agreement.

2. The Austrial Government makes this notification bearing in mind that the provisions of the Long-Term Arrangement on Cotton Textiles are effective.
