TRADE EXPANSION AND ECONOMIC CO-OPERATION AGREEMENT BETWEEN INDIA, THE UNITED ARAB REPUBLIC AND YUGOSLAVIA

The Governments of India, the United Arab Republic and Yugosalvia have notified the Director-General, for the information of contracting parties, of a Protocol signed by them on 16 July 1969 amending the Agreement on Trade Expansion and Economic Co-operation signed by them on 23 December 1967. The 1967 agreement was the subject of a Decision by the CONTRACTING PARTIES dated 14 November 1968.

The Protocol, the text of which is annexed, would add fifty-seven tariff headings or sub-headings to the list of goods to be accorded special tariff concessions in favour of the goods originating in either of the other two participating States. This amendment is proposed to be effective, subject to ratification by competent authorities in the respective countries, from 1 October 1969.

The delegations of the three participating States are ready to furnish any further relevant information and are available for any consultations which may be considered necessary.

PROTOCOL AMENDING TRADE EXPANSION AND ECONOMIC CC-OPERATION AGREEMENT 1967

The Parties to the Trade Expansion and Economic Co-operation Agreement 1967 (hereinafter called the Agreement):

TAKING NOTE OF ITS beneficial impact on trade exchange, and

DESIROUS of strengthening mutual economic co-operation and expansion and development of international trade,

HAVE AGREED as follows:

- 1. With effect from the date of entry into force of this Protocol, the obligations of the Parties to accord special tariff concessions in customs duties in favour of the goods originating in either of the other two Participating States shall include the list of goods attached to this Protocol.
- 2. Upon its entry into force, this Protocol shall constitute an integral part of the Agreement and shall continue to be in force for the period for which the Agreement is in force.
- 3. This Protocol shall enter into force, subject to ratification by competent authorities in the respective countries, with effect from 1 October 1969.

DONE in Cairo on the sixteenth day of July, one thousand nine hundred and sixty nine, in three originals in the English language, all the three texts being equally authentic.
