ADVANCE AGENDA

There is circulated herewith an Advance Agenda for the twenty-sixth session of the CONTRACTING PARTIES, in which are listed the items proposed by the secretariat for inclusion in the provisional agenda. Contracting parties wishing to propose additional items are requested to submit their proposals and supporting documents by 5 January 1970 in accordance with Rule 2 of the Rules of Procedure. The provisional agenda will be distributed by 12 January 1970.

In drawing up the Advance Agenda account has been taken of the proposal made by the Chairman of the CONTRACTING PARTIES at the twenty-fifth session and endorsed by the CONTRACTING PARTIES, that the Council should undertake a wider range of work so that the CONTRACTING PARTIES could concentrate on trade matters of major importance.
